Package Fees



BRONZE - Tenancy Only

One month's rent + VAT (120%) subject to a minimum of £500 + VAT (£600).



SILVER - Rent Collection

One month's rent + VAT (120%) subject to a minimum of £500 + VAT (£600), then 10% + VAT (12%) of the rent collected subject to a minimum of £35 + VAT (£42) PCM.



GOLD - Full Management

One month's rent + VAT (120%) subject to a minimum of £500 + VAT (£600), then 15% + VAT (18%) of the rent collected subject to a minimum of £70 + VAT (£84) PCM. Deposit Registration Fee £25 + VAT (£30).



PLATINUM - Full Management with Rent Protection and Legal Cover (Including Eviction)

One month's rent + VAT (120%) subject to a minimum of £500 + VAT (£600), then 18% + VAT (21.6%) of the rent collected subject to a minimum of £70 + VAT (£84) PCM. Deposit Registration Fee £25 + VAT (£30).

The administration of major works or refurbishment over £5,000 will incur an additional charge of 5% + VAT (6%).
